



The Latest in Clinical Research: New Medicare Policy on Clinical Trials and the Trials of Expanding Litigation Medical Research, Biotechnology & Clinical Ethical Issues Interest Group and Healthcare Litigation & Risk Management Interest Group

Medicare's Clinical Trial Policy has been in effect since September 19, 2000. However, CMS and Medicare contractor implementation of the policy has been inconsistent. CMS recently reconsidered the policy, making minor but important changes. On October 17, 2007, CMS issued a "Decision Memorandum for Clinical Trial Policy" after evaluation of public comments on three previously proposed decisions. This session will highlight important aspects and implications of the newly revised policy, including: routine costs in clinical trials, coverage with evidence development, qualification process for clinical trials, and potential implications of CMS review of clinical trial-related provisions of the Food and Drug Administration Amendments of 2007. Contemporaneously, litigation is growing in the clinical research arena. This session will also analyze claims that have been made in recent cases, claims that have been successful versus those that have not, trends and predictions, and practical approaches for managing risk.

The New Form 990— Major New Information Disclosure Requirements for Hospitals

The redesigned Form 990 represents the first complete overhaul of the Form 990 since 1979, and creates unprecedented increases in the disclosure requirements imposed upon tax-exempt hospitals. For example, the new Form 990 would require, for the first time, the reporting of charity care and community

benefit in a specified format. There are also increased disclosure requirements regarding compensation, tax-exempt bonds, joint ventures, and corporate governance. This session will focus on these key changes, as well as procedures and policies that hospitals will need to implement to address these changes effectively.

Tax-Exemption in the Spotlight—Current IRS and Legislative Initiatives Affecting Hospitals

Tax & Accounting Interest Group

Tax-exempt hospitals continue to be scrutinized for their continued qualification for tax-exempt status. Ongoing IRS compliance/

enforcement efforts have specifically targeted tax-exempt bonds (including a Tax-Exempt Bond Financings Compliance Check Questionnaire sent to approximately 200 organizations), executive compensation, and political campaign activities. In addition, the IRS has released its interim report regarding its Tax-Exempt Hospital and Community Benefit Project. Congress has also continued to focus on the merits of hospital tax exemption. A Senate Finance Committee staff discussion draft of possible legislative changes released recently set forth a series of proposed reforms, including a 5% charity care requirement to maintain tax-exempt status. This session will address these key initiatives and their potential impact on hospitals.

The ABA House of Delegates recently adopted a resolution that encourages lawyers, law firms, legal services agencies, law schools, and bar associations to develop medical-legal partnerships with hospitals, community-based health care providers, and social service organizations to help identify and resolve diverse legal issues that affect patients' health and well-being. 
