Meeting Purpose: Discussion of privacy issues related to pandemic flu planning and response.

Objectives: By the end of the meeting, participants will have:

- o learned of pandemic flu planning efforts nationwide and shared state experiences with pandemic flu planning
- o identified privacy issues related to sharing information in pandemic flu planning as well as the public health agency's role as employer during a flu pandemic
- o sought peer and subject matter expert advice on identified issues
- o propose solutions to challenges identified

Outcomes:

- o Privacy-related gaps identified in current state pandemic flu plans
- O Draft language on privacy and the sharing of health data for pandemic flu preparation and response for potential inclusion in state pandemic flu plans
- O Draft guidelines on public health agency employer roles and responsibilities toward workers during pandemic flu response (e.g., communication with ill or exposed employees; access to employee medical records) for consideration by state public health agencies.
